GENERAL INSTRUCTION

- 1. Application in **Five Copies** must reach University office on or before Dt. 21 /11/2016.
- 2. The candidate must satisfy qualification, experience and age limit criteria on the last date of receiving application.
- **3.** The Applicant must ensure that applicant fulfils the eligibility conditions for the post.
- **4.** Candidates should enclose attested copies of certificates as proof of the evidence of Age, Educational Qualifications, Category, Experience, etc.
- 5. Candidates who are desirous of applying for more than one post will have to submit separate prescribed application form for each post with separate application fee and documents.
- **6.** The University shall verify the antecedents and documents submitted by a candidate at the time of appointment or during the tenure of the service at any time. In case, it is detected that the documents submitted by the candidates are fake or the candidate has undesirable clandestine antecedents/ background and has suppressed the said information, then his services are liable to be terminated.
- 7. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidate.
