If any candidate is unwilling to accept the promotion, his/her unwillingness should be obtained and sent to this office immediately, the seniority of the candidates who has secured same marks as shown in the Annexure, may kindly be fixed as per rules on the subject.

The head of the concerned unit/Division must verify the genuineness of various mandatory certificates of the provisionally selected candidates before appointment.

All head of recruiting units may check eligibility criteria including existing instructions regarding vigilance clearance and outcome of disciplinary/court cases etc. including cases of provisionally permitted candidate and if any irregularity found, it should be reported immediately.

The result is also subject to change due to re-totalling and verification of answer sheets in accordance with the Rules/instructions into the matter.


