Note:-

- (1) Cut-off marks means marks secured by the last candidate in merit list (arrangement of total marks obtained in descending order) of the concerned category.
- (2) As per the instructions of circular No. pavas-1099-mum-13-G.4, Dated: 29.01.2000 of General Administration Department, when Cut-off marks of reserved category candidates is higher than general category candidates. Cut-off marks of reserved category candidates should be lowered down to the Cut-off marks of General category candidates. Accordingly, Cut-off marks of S.E.B.C.(Female) category is lowered down to the Cut-off marks of General category (Female) in this result. Cut-off marks of General Category (Female) is 80.70 marks whereas Cut-off marks of S.E.B.C. (Female) category is 82.10 marks. Therefore, Cut-off marks of S.E.B.C. (Female) category is lowered down to 80.70 marks which is equivalent to the Cut-off marks of General category (Female).
- (3) As per the instruction of circular No. CRR-1096-2213-G.2, Dated: 31.08.2004 of General Administration Department, result of the widow candidates is prepared after addition of Bonus Mark. Bonus marks is 5% marks of the obtained marks by the candidate.

- (4) As per the instruction of Resolution No. CRR-1077-2660-G.2, Dated: 25.02.1980 of General Administration Department, the candidates who have shown the details of sports in their online application are treated as candidates with sports provisionally, hence result of these candidates is prepared after addition of Bonus Mark. Bonus marks is 5% marks of the obtained marks by the candidate.
