(iii)	Candidate should possess the required educational qualifications and experience on the last date of submission of online application.
(iv)	The online application form fee is Rs.1000/- (Rs.250/- for SC/ST Candidates) that is required to be paid using Credit/Debit Card, or online banking only. This amount shall not be accepted in cash, through money order or postal order or through any other financial instrument except Credit/Debit cards.
