1. The following **171** candidates are declared provisionally qualified in the Competitive (Preliminary) Exam conducted by the Gujarat Public Service Commission on 22.12.2018 for the **Advt. No. 75/2018-19, Chief Officer, Class-3, Gujarat State Municipal Chief Officer's Service**. The candidates are declared provisionally qualified for appearing in the Main Written Examination, subject to their fulfilling all conditions of eligibility of Advt. No. 75/2018-19.

In accordance with the rules of the examination, all these candidates have to apply again for admission to the main examination in the detailed application form, as per the instruction of the commission. For the purpose, the public advertisement will be given and the candidates will have to apply within the stipulated time.

2. Details of Category-wise Qualifying standard (Cut-off Marks) and Category wise total of qualified candidates are shown below:

Note:-

- (1) Cut-off marks means marks secured by the last candidate in merit list (arrangement of total marks obtained in descending order) of the concerned category.
- (2) As per Final Answer key declared on dt. 11.02.2019, Five (5) questions are cancelled. Therefore, it is decided by the Commission to equally distribute the marks of cancelled questions among 145 questions on pro-rata basis, as such evaluation has been carried out by treating each question with 1.034 mark for the right answer and (-) 0.310 mark for the wrong/multiple encoded/blank answer in this result
- (3) In the cases, when Cut-off marks of reserved category candidates is higher than that of general category candidates. Cut-off marks of reserved category candidates is lowered down to the Cut-off marks of General category candidates. Accordingly, in this result,
 - (a) Cut-off marks of General Category (Male) is 86.86 whereas Cut-off marks of S.E.B.C. (Male) Category is 88.41 Therefore, Cut-off marks of S.E.B.C. (Male) category is lowered down to 86.86 which is equivalent to the Cut-off marks of General category (Male).

(b) Cut-off marks of General Category (Female) is 70.53 whereas Cut-off marks of S.E.B.C. (Female) Category is 75.46. Therefore, Cut-off marks of S.E.B.C. (Female) category is lowered down to 70.53 which is equivalent to the Cut-off marks of General category (Female).

(4) As per the instruction of circular No. CRR-1096-2213-G.2, Dated: 31.08.2004 of General Administration Department, result of the widow candidates is prepared after addition of Bonus Mark. Bonus mark is 5% mark of the obtained marks by the candidate.

(5) As per the Government Resolution No. CRR-1077-2660-G.2, Dated: 25.02.1980 of General Administration Department, result of the candidates with sports is prepared after addition of Bonus Mark. Bonus mark is 5% mark of the obtained marks by the candidate.
